- IV. Guest Speaker Claudia Daml introduces Tamir Elnabarawy (DHS) speaking on Federal funding- 10:15 10:35 (10:06)
  - Director of Federal Relations
  - Shares PPT presentation
  - In new Congress and Administration
  - Election results from last Nov Republicans retained a majority in the House
  - This dynamic will give any Republican power to delay or impact votes
  - VP Vance can break a tie
  - MN Congressional District 3 was won by a Democrat
  - Key congressional relationships
    - Sr. Smith Sen Finance
    - Senate Indian Affairs Sr Smith
    - House Appropriations rep. McCollum
    - House Majority Whip Rep Emmer
    - Democratics Steering and Policy Cmte Sr Klobuchar
  - Executive appointments
    - RFK as Sec of Health and Human Services
    - CMS Administrator Dr. Mehmet Oz
    - Dir of Office of Mgmt and Budget Russell Vought
    - Dept of Govt Efficiency Elon Musk
  - Federal Funding through resolution that expires March 14, 2025
    - Bi-partisan negotiations going on now to determine funding for each agency
    - If no agreement, may need stop gap or potential shut down
    - Federal Fisal year (FFY) 2025
      - House Republicans proposed 6% spending cut domestically overall
      - MH and block grants were level or slightly increased during Trump's first term
  - Reconciliation Bill
    - Offsets needed to pass
    - Including \$2.3 trillion cuts to Medicaid over 10 years



- Per capita caps
- Lower expansion population FMAP
- Limit Medicaid provider taxes
- Lower FMAP floor
- Debt limit can back Jan 1, 2025
  - House Republicans propose a \$2.5 trillion reduction to mandatory spending over 10 years
  - Default could impact funding for behavioral health
  - Congress has addressed dept limit 68 times since the 1960s
  - Most experts thing budgetary impacts would be felt by summer 2025
- Dept of Govt Efficiency
  - Aims to cut \$2 trillion from the \$6.8 trillion annual budget
  - Has called out unauthorized appropriations
  - Not an official govt agency
  - Could impact federal opioid treatment funding
  - Largest proposed cuts to veterans' health care, opioid treatment, housing
- Federal Aid Freeze
  - Temporarily put in place by OMD memo last week calling for all federal funding to cease pending review
  - Was lifted several days later
  - A temporary restraining order is in place preventing the freezing of this aid
  - DEI funding streams may still be frozen
  - Medicaid portal is operational
  - No interruption of funding for services
  - DHS working w partners to understand the freeze and potentially impacted programs
- Public Charge
  - Process when immigrant applies to enter US or elongate stay
  - Determinations expanded to include certain non-emergency MA benefits,
     SNAP benefits, certain housing benefits
  - Could contribute to a "chilling effect" where people may avoid benefits they are entitled to
  - DHS will continue to build partnerships with legal entities to ensure people receive free and confidential support and services
- Official Poverty Measure
  - OMB increase this annually
  - Ultimately determines eligibility for many benefits (including certain Medicaid and CHIP benefits)
  - A slower rate of inflation could reduce or eliminate benefits for millions of people
- CODEL Insights (Congressional Office)
  - "hard to predict"
  - "waiting with baited breath"

- "don't know much"
- Potential sequence of events
  - House of Reps will release budget resolution by end of week Feb 10
  - Senate adopts budget resolution week of Feb 17
  - Interim; concurrent resolution adopted
  - Feb 27: final vote to adopt concurrent budget resolution
  - April 20: reconciliation package passes House
  - May 26: reconciliation package passes Senate passed by simple majority minority not allowed to filibuster this
  - Administrative action will happen throughout with rule making, etc.

- V. Guest Speaker Jode Freyholz-London introduces Gena Savage (DHS) to give a legislative update- 10:35-10:55 (10:34)
  - Shares slides
  - Legislative Dir for BH since Sept 2024
  - 2025 Session
    - Senate
      - DFL had 1 seat majority and w death of Sr Dziedzic in Dec awaiting special election
      - Power-sharing agreement until after special election
      - Co-presiding officers
      - Doron Clark (DFL) won the seat
      - New power sharing agreement now in place
    - House
      - Originally had 67-67 tie with several seats in contention
      - Judge threw out one seat for Republican that didn't live in the district
      - Legal fight in Shakopee resulted in judge ruling Rep was legal
      - 3<sup>rd</sup> seat in contention for Rep in middle of criminal case
      - Sitting members cannot be tried so she'll remain in seat and face criminal case after session
      - Not currently sitting on any committees
      - Republican have 67-66 majority
      - DFL boycotted first few weeks of session denying quorum
      - Action went to Supreme Court
      - All hearings cancelled for House and no power-sharing agreement is in place
      - Have come to agreement as of 2.5.25 and will be announced today
      - Special election for district 40B seat will take place on March 11
      - Senate didn't contest timeline so this is moving forward



- Was contested in House and Judge ruled date push back to March stands
- Questions
  - Will Speaker remain?
  - Speak of House, Lisa Demuth (GOP), will retain speakership and Rep Tapke will be seated
  - Republicans will also chair Oversight Committee with power-sharing committee
  - How does power-sharing work with GOP chair?
  - They transfer the gavel between leaders
  - Republicans only Chair Oversight Committee, rest are co-chaired
  - Have rep Fischer here who shares some thoughts
  - Committees: will have even numbers of reps/dems in committee and one dem will not have voting rights; once 67-67 this will resind with a rotating gavel
  - · First time this has been tried in MN
- BH Policy Proposal highlights
  - Children's MH Act Clarifications: aligns Children's MH case mgmt. statute with state plan agreement with CMS
  - Current state law requires MA covers CMN-TCM and adult MH-TCM if they meet requirements in case management statute and activities (assessment, clinical supervision, referrals, monitoring, coordination)
  - She's happy to share draft legislative language with Sara for sharing with members
  - Codification of intermediate school-linked grants (originally authorized in 2017)
  - MN has 4 intermediate school districts service more than 20,000 students (SW, NE, Dakota, Henn)
- Next steps
  - Watching House closely on power-sharing
  - Feb forecast coming up and Gov's proposals will be repriced
  - Priorities for caucuses
    - · DFL: childcare, healthcare housing
    - GOP: balancing budget, fraud, waste and abuse

- Claudia thanks Gena for her presentation and good information
- VI. Claudia Daml introduces discussion on next steps for Advisory Council's recommendations 10:55 11:05 (10:52)
  - Hopes all members have read the recommendations that were published (hard copy and electronic copies available – on SAC website)
  - Members are asked to distribute recommendations into hands of people influential in discussing these topics

- Wants workgroups to give some feedback to the Council on what and who are the appropriate next steps to bring recommendations to the next level
- When recommendations were submitted, there was room to note influential people associated with the recommendations; so focus here now and moving forward
- Alison says she doesn't see the recommendations on the SAC website; this may be due to a Communications issue; see previous email from Sara who will also email current copy to all (done during meeting)
- When workgroups next meet, please include a discussion on getting this information to discuss in next Council meeting
- Questions? Clarification?
- Once next steps are gathered from workgroups, Council can move forward on determining how to move recommendations forward
- If anyone isn't yet on a workgroup, this is an opportunity to get involved;
- Please contact Claudia if you have a problem in joining a workgroup (logging on, schedules, finding appropriate topic, etc.)
- Claudia invites Council to recommend appropriate workgroup topics for future consideration
- Elliot: MH Day on the Hill is actually February 20<sup>th</sup> this year
- Claudia encourages members to attend this event and try to speak with your Representative
- Elliot discusses day's activities:
  - Mid-morning education session in Armory near Capital to hear where bills are and talking points for meeting with legislators
  - Time for people to meet with legislators
  - 1:30 speaking at Capital Rotunda for people with lived experience and legislators
  - Email Elliot for questions on how to get a meeting with your legislator or getting a ride; NAMI is helping set people up for these (see chat for email)
  - Claudia says these discussions can be very friendly and welcoming and give an
    opportunity to showcase the recommendations of the Council; can take
    physical copy of recommendations to meeting (request copies from Sara via
    email)
  - · Can bring others to these meetings which may help make this less intimidating
  - Attendance and transportation will be reimbursed by Council
  - Cheryl: Aspire MN is making presentation and Cheryl would like to bring a copy of the recommendations to their planned activities; Sara will get copies to Cheryl
- Please be ready at the next meeting to discuss next steps from workgroups

VII. Claudia Daml introduces presentation of proposed bylaws changes – 11:05 – 11:35 (11:05)

- Bylaws workgroup has been meeting for several months; Claudia thanks members for their participation
- Council bylaws haven't been altered since 2004

- Claudia shares proposed changes; clarifies no voting will take place today; changes need to be reviewed by General Council of DHS first
- Will vote after GCO review
- Encourages members to view current bylaws alongside proposed changes (Sara emailed to members)
- Two areas discussed were things to be changed and also things in the bylaws that need a closer look by members to understand their responsibility; may invite a deeper dive discussion in future by members
- Highlights: pink = proposed changes, green = stated by statute, yellow = points for deeper discussion
- Article 2 Purpose
  - 2 "Review the State MH Plans as part of the block grant application"
    - Isn't part of statute, but in bylaws
    - Need to decide what we want to say instead of statement to bring bylaws into compliance
      - This was created before Council was created
  - Could have liaison from Council that attends BH Committee
  - 5 advise Commissioner on all phases of the development of MH aspects of the bi-annual budget
    - Damir: doesn't the Council need to be empowered legislatively to have authority to make an impact;
    - Community member Katie Brennan agrees
    - Susan: Can lawyer (GCO) answer this question? Help Council find legal avenue to have the authority to do this?
    - Writing is very broad
    - Sara unsure if this would be a responsibility for General Council/Legal;
    - Claudia says this is why DHS leadership attends these meetings to bridge the gap and communicate across groups and budgets
    - Claudia hoping to get core group of members to continue these discussions
    - Rep Fischer: Council does this through recommendations which have budget proposals; need to ask which proposals have been incorporated into DHS's budget
    - Claudia: having a "post mortem" built into recommendation process would be helpful
    - BH Council could be attended by member of SAC; Jode offers to fill this
      role
    - Sara will get Jode connected with those meetings
  - 10 review and comment on all grants dealing with MH and of the development and implementation of state's and local MH plans
    - Unsure of total number, but is in the hundreds
    - Isn't feasible for Council members' capacity
    - Kristine Preston says number is near 1000



- Larger task to change this language, esp given current legislature makeup; may not want to take on during this session
- Proposed language change is to have the "authority" to review and comment on...
- Article 3 membership
  - 11 other members reflecting a broad range of community interests
  - Actual membership of Council and Subcommittee has changed and seats added
  - History of who made the additional seats and why has been lost
  - Juvenile justice is now represented
  - Incarcerated individuals aren't represented and Claudia would like to see these people represented
  - Want language to reflect "authority" to add seats
- Article 4 Subcommittee on Children's MH
  - Typo correcting section 3 to section 4
  - members are appointed by Chair of Council, want language to not limit seats
  - Section 8 add "diverse cultures" to description of people with "adverse MH"
  - This is antiquated language
  - In line with CMS
  - Would need to be statutory change for changing language
  - Section 3 want amendments to broaden geographically represented seats
  - Section 7 want language to say Council "may" have nominating committee to limit obligation
- Article 5 Officers
  - Highlighting Sara's role which used to be called "Director"
  - Want to take out language around titles and refer simply to "staff" to refer to DHS support of these groups
  - Person from DHS supports groups but does not have decision-making authority
- Article 6 change "steering committee" to "leadership team"
- Article 7 block grants
  - Work isn't being done so isn't needed in bylaws
  - Worthy of larger discussion around how to meet these mandates
- Claudia will email these copy of points for discussion to members
  - Section 4 appointments to Children's Subcommittee to include Chair and Vice Chair in decision-making
- Article 8 other committees and work group and policies
  - Section 2 workgroup chairs to be selected by workgroup
  - Individuals who are non-Council members are invited to attend workgroups as non-voting advisors
  - Section 4 powers
  - Chairs to set parameters for decorum in workgroup meetings
  - Section 5 removal

- Chairs to determine who to remove
- Section 6 termination of committees
- Decision through leadership team and Council
- Article 10 meetings
  - Section 5 related to alternate voting and proxies
  - Want to allow designated representatives to vote
  - Alison points out proxies typically don't vote but attend instead of a member
  - Claudia points out the intention is to allow proxies to vote
  - May be an issue for GCO to weigh in on
  - Section 6 Robert's Rules
  - To use revised version from 2023
  - Cheryl: wonders if removal of reference to year would be helpful to always refer to most current version
  - Claudia likes this suggestion and will remove year reference
- Claudia apologizes for taking so much time to go through these; thanks members who
  attended bylaws workgroup meetings; invites members interested in a deeper dive
  discussion to contact her

#### IX. State Agency Updates – Lisa Hoogheem - 11:45 – 12:00 (11:58)

- DOC Shanna Langston/Holly Hanson Shanna shares legislative updates; not directly involved in all conversations but may have to get answers to questions from others; amended application for demonstration waiver; pursuing changes around substance use treatment acknowledging DOC provide more than residential treatment; DOC participated in conversation around race and the age of delinquency; potential grants to juvenile centers to hire counselors; DOC won't take action to legislature but will support work behind it
- DHS Diane Neal and Kristine Preston Kristine Dep AC BH DHS, sitting in for Teresa Steinmetz due to a mandatory state training; liked earlier discussion around bylaws; how to make recommendations to commissioner around budget: Teresa sits on Council and may be able to formalize this process; reviewing and commenting on all grants: only one of many state agencies with MH-related grants; can share RFP opportunities to review and sharing grant updates more with group; agency updates: Jan 13<sup>th</sup> announcement Jodi Harpstead was to leave her Commissioner position; in role since 2019; supported work to divide DHS into 3 new agencies; GO announced Sherene Ghandi (Dep Commissioner) will serve temporarily in role; has overseen budgeting, strategy and effectiveness work; Re: Tamir's presentation on Federal regulations; DHS is watching closely and responding to orders, like the funding freeze; hearing from community providers on impact of loss of funding; DHS working to make these impacts clearly communicated; situation evolving at rapid pace; acknowledges stress and uncertainty; happy to answer any questions

- Jode: regarding federal grant which serves 3000 interactions per month and which will end July 2025; don't have RFP for this work; any news from DHS?
- Kristine: silence is better than other language but DHS doesn't have any updates
- Bravada: how will federal funding impact diversity and multiculturalism in MN which is a leader in DEI; will other funding be needed for grants supporting these populations?
- Kristine: knows there a focus on DEI activities; unsure how this intertwines with BH and inherent disparities; appreciates angst and will provide updates once DHS has one
- Bravada wonders if a change in language away from DEI to support equity in more subtle ways; hopes Diversity and Outreach workgroup will have some suggestions
- Kristine: MN's strategic plan is in place and hasn't changed as a result of federal funding; may need to couch language to preserve federal funding so DHS is open to this
- MDE Tom Delaney MDE hosting MN School Health Conference (1st ever) March 3rd in St. Cloud; for practitioners and broader; school nurses, etc. but not limited to this role/perspective; public health is the wider focus; 3 strands: leadership, legalities and licensure; will put together collaborative working partnerships; link in chat for info and registration; free webinar series on social, emotional and behavioral interventions being culturally responsive and trauma-informed; next event Feb 12th; planned to April; CECs may also be offered; please share with your network; opportunity for schools to act as demonstration projects for implementation of some topics rather than just being aware; link in chat;
- Jode asks if Tom has seen restrictions at DOE resulting from funding action
- Tom: not yet until decision has been made; actively scanning areas and agencies for word of changes
- MDH Alyssa Green/Anna Lynn not present
- DEED no replacement for Claire yet
- Other agencies: none

#### X. Updates from Members – Jode Freyholz-London – 12:00 – 12:10 (12:18)

- Bravada: thanks Tom from MDE for addressing disproportionate impact to BIPOC communities to issues being addressed in recommendations
- Regarding recommendations: acknowledgment is good but action is important; didn't see statements in recommendations to include actions beyond awareness and moving into action
- Bravada happy to help identify actions during recommendation process
- Dani: working on Bill jacketed and to be introduced to Senate for private ins health ins
  coverage for AAC devices (children with autism use) (letterboard, pictureboard,
  speaking devise); Sr Wicklund helped draft and Sr Abler co-authoring; Gillette also
  helping and on agenda for Council on Disabilities consideration; encourages members
  to support these efforts as many children with MH issues use these devices
- Jode: LAC had wonderful participation with many participants; thanks Sierra for leading event; will do this again in another quarter
- Elliot will put link in chat for comment on proposed legislation from NAMI

- DOC has rule making process for jails; having public meetings of an advisory group
  which can be significant and involve MH assessment and medication access; link to
  this meeting in chat plus more information; will be meetings every 3 weeks
- XI. Membership and DHS Updates Sara Nelson 12:10 12:15 (12:25) tabled
  - If anyone is having an issue with uploading W9s and register for SWIFT, let her know and she hopes to have information to help new members
  - Workgroup chairs: please type updates into chat to share or send to Sara who will distribute with meeting notes
  - Dave Lee: will send email regarding state fair which will need more volunteer support this year
- XII. Lisa Hoogheem Introduces Gary Travis (DHS) and Andrea Simonett (DHS) for updates from DHS Homelessness, Housing and Support Services Updates 12:15 12:55 (12:26)
  - Gary oversees BH housing programs (see slides)
  - 4 programs serving BH needs ppl and ppl with MH and substance use
    - Projs for Assist in transition from Homelessness
    - Bridge regional treatment ctr
    - Housing w Support for adults and serious MI
    - Crisis housing assist program
  - PATH and HSASMI and Crisis Housing assistance programs serve ppl with serious MI or co-occurring serious MI and substance use disorder
  - "serious mental illness" is defined in MS 245.462
  - State PATH program now include ppl with only substance use disorder
  - Align with Comprehensive Adult MH Act housing mission statement
  - PATH is federal and state program
  - Goal is transition ppl out of homelessness into housing and services
  - Provides homeless outreach and case management services (clinical asmt, habilitation, SU treatment, etc. – broad interpretation)
  - Currently supports 13 projects across the state and projects an additional 4 projects
  - New PATH funding MS245.991
  - Funding: PATH federal formula grant \$832,870 and historic state match \$618,049
  - New state PATH funding adds approximately \$4.79M per year for a total of \$6.14M per year
  - Damir: thoughts of fraud and abuse in recent news in MN and displacement of clients who were homeless; fear in providers for clients who may become homeless and continuation of services; has never heard of these grants; how does this interface with provision of services? How can awareness grow and get the word out?
  - Gary: biggest factor in lack of information is the small size; prior to 2023 there were only 7 projects supported; outreach service may be integrated by another agency or with another service and may not be branded as "PATH"; Henn Co has it integrated into social services
  - Hope to have 17 project in future

- 13% of funds are federal so cessation of funding would cause severe impacts
- PATH outcomes:
  - 2023 homeless outreach was 2,615
  - Case mgmt. services = 878
  - People able to access MH and SUD treatment: community MH services 49.84%; SUD 6.4%
  - Transition from homeless to housing: 13.8% referred to permanent housing and 10.8% accessed
  - Increases not projected to be high as they fall under co-occurring situations
- Housing Supports for Adults with Serious Mental Illness
  - Goal is to help people who are homeless obtain and retain permanent supportive housing
  - May provide outreach, case mgmt., housing transition, housing sustaining, sitebased housing, community support services and direct assistance funding
  - Uses SAMHSA evidence=based practice for permanent supportive housing
  - Currently supports 16 projects across MN
  - In 2023 served 848 people for 25 projects
  - New HSASMI program state MS246.992
  - Funding: HSASMI base \$4.55M total per year
- HSASMI program outcomes
  - Used range of EBPs and promising practices from MN Inventory/Mn Mgmt and Budget
  - Number of individual that were able to transition went from 3-13% of participants
  - 81.37% were able to retain permanent housing
  - satisfaction with housing
    - 21.84% wanting or planning to move (could be for positive or negative reasons)
    - 68.71% not wanting or planning to move
- Crisis Housing Assistance Program is key tool for prevention
  - Goal is to prevent homelessness while receiving inpatient or BH treatment including MH and SU treatment
  - Contracting with ARC MN for online portal of applications (link in PPT)
  - Provides short-term assistance such as rent, mortgage, lot fees and utilities for
     90 days for people who are of low to moderate income
  - Funding: \$610,000 annual state funding base
  - Use: 183 applications funded
  - Ave monthly inc = \$1220
  - Ave household size 1.55
  - Ave age 38 (20 67)
  - 63% female, 35 male 2% transgender or X
- Bridges and RTC Program
  - Need partnerships to make these work

- Programs administered by Mn Housing MS462A.2097
- Eligibility: ppl living in an institution, segregated housing or correction supervision and ppl who will be homeless upon program exit
- 18+ and families with children
- 2023 served 568 people
- Funding: Bridges RTC funding \$192,000
- Partnerships are critical for homeless and housing programs
  - Bridges
  - · Housing Trust Fund
  - HUD section 811
  - Adult health initiatives: housing support for adults with serious MI, project for transition assistance, client outreach, community support and housing subsidies
