Revised: Pharmacy billing and support changes for outpatient fee-for-service functions effective Nov. 4

We revised this message to state the new pharmacy billing and support changes for outpatient fee-for-service functions are now in effect. We also added hyperlinks to the related Minnesota Health Care Programs Provider Manual sections and Minnesota Medical Assistance Portal (hosted by Prime Therapeutics).

Outpatient pharmacy services claims processing and related pharmacy benefit functions transitioned from the Minnesota Department of Human Services (DHS) to Prime Therapeutics (formerly known as Magellan Health) on Nov. 4, 2024. This impacts only the fee-for-service outpatient pharmacy benefit. Managed care organizations will continue to provide outpatient pharmacy benefits for members enrolled in their plans.

DHS has contracted with Prime Therapeutics to provide the following services:

- outpatient pharmacy claims processing (point-of-sale claims)
- outpatient pharmacy member and provider call center (24 hours a day, 7 days a week)
- drug rebate system and administrative support
- prior authorization determinations for outpatient pharmacy and provider-administered drugs
- retrospective drug utilization review
- state maximum allowable cost and 340B ceiling price file
- preferred drug list

Complex transitions referral form to open to all lead agencies

In November 2023, the Complex Transitions Team started as a pilot project. The team worked with specific hospitals in the Twin Cities and Duluth to support transitions from the hospitals for people who face complex needs and difficulties connecting with community services.

During the pilot project, the Complex Transitions Team accepted limited referrals. In collaboration with the county state work group and regional lead agencies, the [Complex Transitions Referral Form, DHS-8507](#) will open to all lead agencies effective Nov. 4, 2024.

Claims process for paying a spouse or parent of a minor for PCA services

The Minnesota Department of Human Services (DHS) announced in July that spouses and parents of minors can serve as paid personal care assistance (PCA) workers for their Minnesota Health Care Programs enrolled family members effective Oct. 1, 2024.

When PCA provider agencies submit claims for family member PCAs, use code T1019 with modifier U2. The U2 modifier identifies the service was provided by a spouse or parent. The U2 modifier is not on the service authorization but needs to be added to the claim. The lead agency does not need to update the service agreements for these claims.

If you have not yet submitted claims for dates of service beginning Oct. 1, 2024, to now, make sure you include the U2 modifier.

If you have already submitted claims for dates of service from Oct. 1, 2024, to now and services were provided by a spouse or parent, **replace your claim** and include the modifier U2.

Final reprocessing of paid individualized education plan (IEP) claims for fiscal year (FY) 2022-2023 underway

Minnesota Health Care Programs has calculated and reviewed the final IEP rates for the period from July 1, 2022, to June 30, 2023. Additionally, we have entered the final rates into the Medicaid Management Information System and will reprocess the paid IEP claims for FY 2022-2023 on Wednesday, Oct. 30, 2024. The reprocessing usually takes one to two weeks, although the duration may vary based on your school district's position in the queue.

Note: If you would like your remittance advice to only include the finalized paid claims for FY 2022-2023, do not submit claims until your school district is reprocessed. Your school district still needs to be processed if your claims are not reflected on the following warrant dates:

- Nov. 5, 2024
- Nov. 19, 2024
- Dec. 3, 2024
- Dec. 17, 2024
- Dec. 31, 2024 (if needed)

Denied dental claims for CDT Code D0120 reprocessed

Minnesota Health Care Programs (MHCP) has reprocessed CDT Code D0120 periodic oral evaluation dental claims denied for exceeding maximum benefit limits. The benefit limit change was effective starting Jan. 1, 2024, and is now allowed twice per year.

Providers should not submit claims for this service at this time to prevent the claim from being denied. We will post a message on this webpage when the system is updated and claims can be submitted. Medical Assistance (MA) coverage available for mental health services in special education starting Oct. 15

Certain mental health services delivered on or after Oct. 15, 2024, may be covered by MA. Minnesota schools and school districts can access this benefit for identified mental health services provided as part of an Individualized Education Program or Individualized Family Service Plan when consistent with the criteria outlined in the [Mental Health Services in Special Education \(MH-SPED\) \(School Social Work Services\)](#) section of the Minnesota Health Care Programs Provider Manual. Additionally, the Minnesota Department of Education and the Minnesota Department of Human Services have launched a new [School Mental Health Services](#) webpage to provide access to resources and training.

Bond requirements for PCPOs transitioning to CFSS

The Minnesota Department of Human Services (DHS) would like to clarify that personal care provider organizations (PCPOs) who received a notice to revalidate and are transitioning to Community First Services and Supports (CFSS) can update their surety bond when their current surety bond expires.

DHS had previously informed revalidating PCPOs transitioning to CFSS that they must submit the [CFSS Agency Surety Bond \(DHS-8558\) \(PDF\)](#) to replace the [PCA Agency Surety Bond \(DHS-6033\) \(PDF\)](#) to revalidate. With new information, DHS determined that PCPOs only need one bond and the DHS-6033 surety bond can be replaced with the new DHS-8558 surety bond when the 6033 bond naturally expires. DHS will mark revalidation for PCPOs completed once all documents and the site visit are complete.

Once the surety bond expires for an enrolled PCPO providing CFSS, the organization must submit the new [CFSS Agency Surety Bond \(DHS-8558\) \(PDF\)](#). (pub. 10/16/24)

DHS seeks customized living quality improvement grant proposals

The Minnesota Department of Human Services, through its Aging and Adult Services Division, is requesting proposals from qualified responders to improve overall quality of life for members receiving customized living services through the Brain Injury (BI), Community Alternatives for Community Inclusion (CADL) or Elderly Waiver (EW) programs.

During state fiscal years 2025-2026, DHS estimates that up to \$2 million will be available to successful responders. One-time grants will be available ranging from \$25,000 to \$250,000.

Responders must show how their proposal can positively affect the domains of quality identified in a 2019 University of Minnesota (UMN) report on quality measurement in assisted living. Find more information on these domains of quality in the [UMN's complete report](#).

Early Intensive Developmental and Behavioral Intervention (EIDBI) draft state plan amendment public comment period open

A public comment period is open now through Nov. 2, 2024, for draft state plan amendment (SPA) 24-39 to the Medicaid state plan.

[SPA 24-39 \(PDF\)](#) makes changes to:

- provider qualifications for EIDBI qualified supervising professionals,
- child and family psychoeducation,
- mental health services, and
- adult rehabilitative mental health services (ARMHS)

The proposed changes have an effective date of Jan. 1, 2025. Minnesota Department of Human Services (DHS) does not expect these changes to have a fiscal impact.

These changes are authorized by:

- EIDBI: Minnesota Statutes, 256B.0949, subdivision 17.
- Child and family psychoeducation: Laws of Minnesota 2024, Chapter 127, article 61, section 23.
- Mental health services: Laws of Minnesota 2024, Chapter 127, article 61, section 7 (clinical trainee requirements).
- ARMHS: Laws of Minnesota 2024, Chapter 127, article 61, section 20.

Minnesota Health Care Programs (MHCP) members notified about pharmacy billing change

The Minnesota Department of Human Services (DHS) started sending letters to current fee-for-service MHCP members on Oct. 9, 2024, through U.S. Postal Service about DHS contracting with Prime Therapeutics to process outpatient pharmacy claims effective Nov. 4, 2024.

The letter includes BIN number information including what is on their current member ID card and the new billing information (RxBin, RxPCN and RxGroup). We instructed members to bring the letter to their pharmacy to prevent delays in processing their prescription bills. Members will receive new member ID cards in the future.

Also beginning Nov. 4, 2024, Prime Therapeutics will have a new member pharmacy call center available at 844-575-7887 for member questions about getting prescriptions. (pub. 10/10/24)

Early Intensive Developmental and Behavioral Intervention (EIDBI) behavior analyst provider requirement update effective Jan. 1, 2025

Behavior analysts enrolled as Minnesota Health Care Programs (MHCP) EIDBI providers must meet one of the following criteria to continue providing behavior analysis services effective Jan. 1, 2025:

- Be a licensed behavior analyst according to Minnesota Statutes, 148.9981 to 148.9995. Refer to Article 19, section 1, subdivision 7 in Chapter 127 of [Minnesota Session Laws – 2024, Regular Session](#).
- Qualify for an exception to licensure under Minnesota Statutes, 148.9987. Refer to Article 19, section 7, in Chapter 127 of [Minnesota Session Laws – 2024, Regular Session](#). A psychologist licensed under Minnesota Statutes 148.88 to 148.981 is not required to be a licensed behavior analyst.

You may not use the title “behavior analyst” or a title implying you are licensed or qualified to provide behavior analysis services unless you are a licensed behavior analyst or exempt from licensing.

You may apply to become a licensed behavior analyst if you are not currently licensed and want to provide behavior analysis services. Submit your application as soon as possible to avoid processing delays. (pub. 10/8/24)

Personal Care Provider Organizations (PCPOs) transitioning to Community First Services and Supports (CFSS)

Actively enrolled PCPOs that have not received a revalidation letter that are transitioning to CFSS are required to send in the following to ensure proper billing of services:

- Proof of successful completion of the [CFSS transition test for PCA agencies](#) or completion of [Steps for Success](#) with “CFSS” in the title of the completion certificate.
- [CFSS Agency Provider Agreement Addendum \(DHS-8160A\) \(PDF\)](#)
- [CFSS Provider Agency Assurance Statement \(DHS-8560\) \(PDF\)](#)

These can be submitted via fax or using the [Minnesota Provider Screening and Enrollment \(MPSE\) Portal](#).

Ensure all provider credentials are updated on provider records, such as, but not limited to, liability insurance, surety bond, fidelity bond, workers compensation, or any other required forms.

Licensed marriage family therapists and licensed professional clinical counselors encouraged to enroll with Medicare

Medicare is the main payer beginning Jan. 1, 2024, for certain mental health services provided to people who have both Medicare and Medical Assistance (Minnesota’s Medicaid program) if the services are provided by licensed marriage family therapists or licensed professional clinical counselors.

We encourage licensed marriage family therapists and licensed professional clinical counselors to enroll with Medicare to bill services for dually eligible members. Minnesota Health Care Programs (MHCP) considers Medicare primary to MHCP coverage. You must bill services covered by Medicare to Medicare first. Services provided in hospitals, community mental health centers and opioid treatment programs are included.

Claims billed directly to MHCP may be denied without a Medicare explanation of benefits.

Denied dental claims for maximum and minimum age restrictions reprocessed

Minnesota Health Care Programs (MHCP) reprocessed dental claims denied for maximum and minimum age restriction. Reprocessed claims are for dates of service Jan. 1, 2024, through Aug.13, 2024.

The maximum age restriction was removed from the following CDT Codes effective Jan. 1, 2024:

- D8010 - Limited orthodontic treatment of the primary dentition
- D8020 - Limited orthodontic treatment of the transitional dentition
- D8030 - Limited orthodontic treatment of the adolescent dentition
- D8040 - Limited orthodontic treatment of the adult dentition
- D8070 - Comprehensive orthodontic treatment of the transitional dentition
- D8090 - Comprehensive orthodontic treatment of the adult dentition
- D1351 - Sealant-per tooth
- D1352 - Preventive resin restoration in a moderate to high caries risk patient permanent tooth. (minimum age of 6 has been changed to 0 with no maximum age)
- D2381 - Resin two surfaces posterior primary
- D2930 - Prefabricated stainless steel crown primary tooth

Individualized Education Plan (IEP) interim rates for fiscal year (FY) 2024-2025 sent to school districts

The Minnesota Department of Human Services sent IEP interim rates for FY 2024-2025 to school districts on Sept. 26, 2024. You will find your rates document in the **Miscellaneous Received** folder of your MN-ITS mailbox under the file type IEP. The file is named "NPI#_IEP_20240926_School ID_InterimRate_FY2025."

This document includes the interim IEP rates for the period from July 1, 2024, to June 30, 2025. The final IEP rates calculated for FY 2022-2023 will become the interim IEP rates for the current school year (July 1, 2024, to June 30, 2025). These rates are calculated based on actual time and encounter data submitted by the school districts and final data from the Minnesota Department of Education (MDE) for FY 2022-2023.

Information sessions on Medical Assistance coverage for mental health services in special education

Beginning Oct. 15, 2024, Minnesota schools and school districts can access Medical Assistance (MA) for identified mental health services provided as part of an Individualized Education Program (IEP) or Individualized Family Service Plan (IFSP). MA is Minnesota's Medicaid Program.

The Minnesota Department of Education (MDE) and Minnesota Department of Human Services (DHS) are collaborating in this effort and have developed statewide informational webinars to update schools and districts on how to receive MA reimbursement for identified mental health services provided as part of an IEP or IFSP.

Early Intensive Developmental and Behavioral Intervention (EIDBI) added to the Minnesota Health Care Programs (MHCP) provider e-mail subscription list

Qualified licensed professionals may apply for positions with the External Program Review Committee (EPRC)

Qualified licensed health and mental health professionals may apply for part-time positions with the [EPRC](#). The committee:

- Works with service providers licensed under Minnesota Statutes, 245A and 245D to develop strategies for phasing out the use of restraint and improving quality of life for people with disabilities.
- Makes recommendations to the Minnesota Department of Human Services (DHS) on policies and initiatives that impact [Minnesota Rules, 9544](#), also known as the Positive Supports Rule.

Committee members are expected to:

- Participate in two, two-hour committee meetings per month. One meeting is held on the first Thursday of every month from 2 - 4 p.m. The other meeting can be adjusted to find a time that works for new members.

- Individually provide guidance directly to service providers and other care team members.
- Work collaboratively with other committee representatives and state staff to share information, draft materials, identify committee priorities and plan committee activities.

Compensation

Training and technology for the position will be provided and members will receive compensation of \$416 per month (\$4,992 per year) plus expenses. State-employed staff who participate in committee activities during their working hours do not qualify for compensation but may apply for the committee with supervisor approval.

Qualifications

DHS is looking for professionals with excellent customer service and teamwork skills. To qualify, professionals must:

- Demonstrate expertise and knowledge on the use of [positive support strategies](#) as alternatives to the use of [restrictive interventions](#).
- Maintain and be actively licensed within a profession listed under either [Minnesota Statutes, 214.01](#), subdivision 2; or [Minnesota Statutes, 245I.04, subdivision 2](#).
- Pass a background check.

Apply

Visit [External Program Review Committee, Office of the Secretary of State](#) to apply for an open position. Submit a resume and cover letter that highlights and explains how you meet the qualifications.

Professionals that work for service providers licensed under Minnesota Statutes, 245D and 245A are welcome to apply, though they are prohibited from working on cases related to their 245D/245A employer or affiliates.

Timeline

We will interview applicants for the committee in October or November 2024. New member terms will start in early 2025. Committee member terms may last up to four years and can be renewed. (pub. 9/24/24)

New HT modifier available for mental health mobile crisis response services

Mobile crisis services providers can now use the HT modifier for claims where two or more individual providers are providing a mobile crisis assessment, intervention or stabilization.

The HT modifier is allowed if one responder is available virtually and another responder is in person. The HT modifier has the same reimbursement rate as other mobile crisis services billing codes. Providers can immediately start adding the HT modifier to the rendering provider's claim.

Minnesota Health Care Programs (MHCP) dental benefits now include CDT Code D0210 - intraoral comprehensive series of radiographic images (FMX)

MHCP dental benefits now cover CDT Code D0210 - intraoral comprehensive series of radiographic images (FMX) - under the following two conditions:

- Covered once every two years in an office setting (or)
- Covered as often as needed in the operating room or ambulatory surgical center

CDT Code D0210 is retroactive back to July 1, 2024. Providers should resubmit denied claims for this service if it occurred on July 1, 2024, or later.

Update: Personal care provider organization (PCPO) revalidation started Sept. 16

Minnesota Health Care Programs (MHCP) sent revalidation notices to PCPOs (provider type 38) on Sept. 16, 2024. Providers due for revalidation will find the revalidation notice in the **PRVLTR** folder of their MN–ITS mailbox. We will mail the revalidation notice via the U.S. Postal Service to the credentialing address on the enrollment record if you have not set up a MN–ITS mailbox.

With the transition of PCPO to CFSS on Oct. 1, 2024, you have two options for revalidating your PCPO record(s).

1. The first option is you can submit a PCPO revalidation request. Refer to the [PCA Provider Agency Enrollment Criteria and Forms](#) section of the MHCP Provider Manual for more information about revalidating as a PCPO agency.
2. The second option is to transition your agency to a Community First Services and Supports (CFSS) agency. Refer to the [CFSS Enrollment Criteria and Forms](#) section of the MHCP Provider manual if you choose to transition to CFSS.

If you choose to revalidate as a PCPO, do not send any revalidation documents until you receive your initial revalidation notice. You will receive a revalidation notice when you are due for revalidation. Review the revalidation schedule in the [Provider Screening Requirements](#) section of the MHCP Provider Manual for more information.

You may also check if you are due for revalidation using the [MPSE portal](#). Log into MN–ITS and click on the MPSE portal link. This will open the **Manage Portfolio** page. Go to the **Revalidations** section and click on the **Manage Enrollment Records Due for Revalidation** link. This link will take you to the **Enrollment Records with a revalidation in-process** page which will display a list of enrollment records due for revalidation.

Substance Use Disorder (SUD) services State Plan Amendment (SPA) approved

Minnesota Department of Human Services (DHS) received approval for a SPA related to SUD treatment services. The SPA introduces several key changes that will impact residential SUD services:

- **Residential American Society of Addiction Medicine (ASAM) levels of care:** The amendment defines residential ASAM levels of care.
- **Unified residential treatment rates:** The SPA includes one rate for residential treatment providers for individuals covered by the Behavioral Health Fund or Medical Assistance. We are currently updating the claims system to allow for payment of the higher rate for behavioral health fund. We will communicate additional information via email and MN–ITS mailbox.

- **Daily skilled treatment requirement:** A daily skilled treatment service is required for high-intensity residential treatment (ASAM 3.3 and ASAM 3.5). There is no longer a requirement to provide 30 hours of treatment per week for ASAM 3.3 and ASAM 3.5 levels of care.
- **Low-intensity residential levels:** The SPA outlines two levels of low-intensity residential treatment, one requiring at least five hours and the other at least 15 hours of skilled treatment services along with their respective rates.
- **Billing for missed services in residential levels of care:** Programs can continue to bill a per diem rate based on a client's intensity level when a treatment service is missed. The reason for missing a service must be client centered. The program must document both the reason for the client's absence and the interventions taken.
- **Holiday scheduling flexibility:** Effective Aug. 1, 2024, service hours during a treatment week may be reduced to accommodate federally recognized holidays. This is applicable for outpatient services and ASAM 3.1 low-intensity residential treatment. High-intensity residential treatment (ASAM 3.3 and ASAM 3.5) is still required to provide daily skilled treatment services.

DHS begins EVV compliance enforcement

As of Sept. 1, 2024, DHS began to enforce EVV compliance and review EVV usage for all providers, regardless of payer, including financial management service (FMS) providers and managed care organizations (MCOs). This change ends the EVV soft launch phase.

For services that require EVV, provider agencies must:

- Immediately enroll with the HHAeXchange (HHAX) system. To review the steps to begin the enrollment process, refer to the [EVV provider onboarding guide](#) webpage.
- Use their EVV systems.
- Send EVV visit data to the state aggregator.

Provider agencies may be at risk for nonpayment of services if they:

- Do not make a good faith effort toward EVV compliance.
- Do not meet MN EVV requirements.

Nonemergency Medical Transportation (NEMT) services providers cannot bill Minnesota Health Care Programs (MHCP) for Modes 3 and 4

NEMT services providers cannot bill MHCP for Mode 3 – Unassisted transport (curb-to-curb) and Mode 4 – Assisted transport (door-to-door and door-through-door) services; and must contract with one of the following organizations for billing and reimbursement.

- Medical Transportation Management – Minnesota Nonemergency Transportation (MTM-MNET)
- SmartLink
- Local county or tribal agency

Reminder: Waiver allowing PCA agencies to bill for services provided by certain family members ended Nov. 11

We explained on Sept. 27, 2023, on this webpage that the temporary waiver allowing personal care assistance (PCA) agencies to hire certain family members to be paid to provide PCA services ended Nov. 11, 2023. This is a reminder this temporary waiver ended Nov. 11, 2023.

The family members that the waiver allowed to be paid for providing PCA services were:

- Parents of minors
- Stepparents of minors
- Legal guardians of minors
- Spouses

The Minnesota Department of Human Services (DHS) previously announced an extension of the end date for this waiver in a [May 12, 2023, eList](#).

Effective **Nov. 12, 2023**, Minnesota Health Care Programs (MHCP) or a person's managed care organization (MCO) cannot pay PCA agencies for claims with dates of service provided after Nov. 11, 2023, by these family members.

People and families should work together with their PCA agency to develop an alternative plan for providing PCA services. They can contact their lead agency (county, tribal government, or managed care organization) for additional support if they continue to struggle with staffing.
