- The competitive workforce factor (CWF) is 6.7% and is applied to the direct care hourly wage in the frameworks. Some services can be delivered either in person or via remote support. - Customization for deaf/hard of hearing, requiring signing = \$2.50 wage add-on
- Nursing wages in the residential and day frameworks are as follows: RN wage = \$38.03; LPN wage = \$23.06
- Adult day bath is priced at \$7.01 per 15-minute unit
- Meals in adult day services are as follows: \$6.07 per meal and \$2 per snack
- Customized living and 24-hour customized living are priced using the Customized Living Tool and do not include the CWF component
