## Why am I getting this notice?

This message is to notify you that the Minnesota Department of Human Services (DHS) is ending the Housing Stabilization Services (HSS) benefit under the Medical Assistance program. DHS has identified you as someone approved to receive this service. The benefit will not be available to anyone enrolled in Medical Assistance **after October 31, 2025**. Eligible HSS providers can continue to deliver services to enrolled individuals through Oct. 31, including helping you connect with other assistance. You can also <u>find resources</u> on our webpage at mn.gov/dhs/housing-resources/.

## Why is this happening?

In recent months, DHS has stopped payments to many Housing Stabilization Services providers suspected of fraud. DHS no longer has the federal approval to administer the housing stabilization service (Laws 2017, 1<sup>st</sup> spec. sess., chap. 6, art. 2, sec. 10). DHS is taking the required actions to end the program.

## What can I do now?

You have the right to file an appeal, but because the HSS benefit is being terminated, a fair hearing will not be granted, and HSS services will not be available during the appeal request period.
