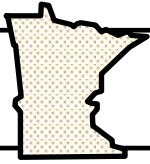

II. Land Acknowledgement – Cici Requests Member Volunteer, 10:08 – 10:10 (10:03)

- We, the members of the State Advisory Council on Mental Health and Subcommittee on Children's Mental Health, acknowledge that the wealth of this country was built on stolen land and with enslaved and underpaid labor of African American, Native American, and Immigrant people. We acknowledge that the recent global uprising, which was sparked by the murder of George Floyd here in Minnesota, paired with the COVID-19 pandemic, makes for a time of profound uncertainty, shame, fear, and distrust. 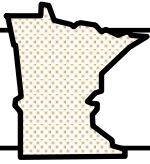
IV. Legislative Recommendations from Work Groups – Lisa Hoogheem - 10:15-11:20 (10:06)

- Family Systems and Prevention – Anna Lynn
 - No recommendations; hoping to use previous recommendations which were not acted upon and which may still be relevant
 - Cici reminds that **June's meeting will be last chance for groups to present**
- Recovery Supports – Angie Schmitz
 - Took new position with State and cannot write recommendations due to position
 - Needs help from members/others to write
 - **Jode Freyholz-London offered to assist in writing this group's recommendations**
- Mental Health and Schools - Amy Jones (is travelling and unable to present)
 - Calls for other member to present updates
 - Alyssa Greene will present recommendations – many come from previous year's recommendations
 - Fully fund per-pupil allocation and solutions to workforce challenges in filling positions
 - Increase MH licensure requirement for staff including digital MH
 - Include 504 students within EIP reimbursement program
- Outreach to Diverse Communities – Dr B
 - Recommendations are not fully organized yet
 - Develop more community support resources among BIPOC populations for MH treatment and issues
 - Outreach plan to make funding accessible to people who've been jailed and have limited support
 - Increased peer support specialists and increase pay in line with other professions and livable wages; especially people of color and for those with diverse linguistic needs
 - Advance the language and increase access to provide \$ to orgs that would train and provide grants for case management (i.e. CEMIG grant)

- more cultures provided technical assistance for grant writing
- advancing school link grants with technical assistance including charter schools and carving out for multi-cultural students
- look at CPS and endorse new paradigm with community engagement around future practices
- reimbursement parity for Medicaid
- DHS requirements to qualify targeted organizations broadening to include more BIPOC organizations
- Dr. B will write up recommendations and appreciates input from members
- If other group's priorities are similar, ensure recommendations are supporting each other
- Asks members for anything to add or questions around these recommendations
- Reminds members of this group's land acknowledgement declaration and commitment to include BIPOC considerations in every recommendation
- Sara will connect Anna Lynn and Dr. B
- Lisa acknowledges need for workgroups to include diversity in recommendations and thanks Dr. B for challenging group to maintain this focus
- Lisa calls out overlaps between this group's recommendations with other groups and encourages workgroup chairs to reach out to Dr. B to ensure connections are made
- Juvenile Justice and MH Group
 - Recommendations around juvenile competency attainment in MN needing clarity: have made some tweaks to language
 - Worked with Elliot on changes
 - Juvenile competency rule be updated and new process means getting children and family in courts asap, timely access to wraparound services, aligning process with needs of all parties, prioritizing restorative justice approach and increasing lower age of delinquency from 10 to 13
 - Alison asks who is doing assessments for competency?
 - Cici thanks Alison for these good points and agrees there's a lack of guidelines around who does the assessments; agrees a recommendations having more specificity on this included
- Member Corey update on his new company
 - Youth Diversion program called House Raising – 10-25 year old apprentice-based education and tailor-made services
 - Case oversight, case management, family assistance and support, apprenticeship experiences in the arts and trades for community connections
 - Addressing many independence topics as well: managing daily life, healthy eating, financial management, etc. as part of apprenticeship
 - Currently in start up phase
 - Looking to take on 5 young people to begin
 - Need starting place as there is skepticism in working with a new organization
 - Corey has long experience of creating diversion programs in the counties

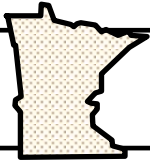

V. Conversation regarding Governor's budget and Star Tribune editorial – Cici - 11:20-12:00
(11:23)

- Kirsten Anderson with Aspire MN – providing services to young people regarding MH
- Aspire focused on billing rates and encouraging media engagement around MH crisis and emphasizing rate structure as solution
- Launched proposal for legislature
- Think this crisis is temporary as long as access through workable rates
- Editorial walks through argument
- 2023 showed inflation for coming years and proposing rate study
- Critical access rates of 23.7% for specific providers with specific MH access; was passed earlier; this rate was not congruent with MN's typical rates; will sunset over 3 years; \$25m;
- Aspire argues need rate structure that works and makes sense to payers
- Confusion over current rate structure
- Suggesting initiation of investments to go into this once current rates sunset
- Editorial suggests there is time in legislature to seek additional investments; remaining engaged in House and Senate bills moving forward and including MH rates; neither is fully baked;
- Lisa: how can committee support this work? Kirsten: need leadership and Gove, Senate Majority leader and speaker to know of the need for more MH investment; legislature adjourns May 20th; welcomes Council's voices
- Kirsten will send alerts and updates to Council
- Members can phone and email local reps to change spending targets
- Dr. B: some providers make more than she does for same work when she works with diverse and poor people; how is this? Some doctors negotiate rates with insurance companies; mention those receiving services in this work; need to get wealth insurance companies with high deductibles behind this work;
- Chat: some providers refuse this work
- Aspire advocates for family-centered MH models including respite for families; are mostly focused on rates; lack of resources
- These are outpatient Medicaid rates
- Challenging to get negotiating power
- Need leadership to advocate wholesale
- Do other states do this better as an example to call on?
 - Natl Org of States Mtg on Children's MH
 - Most states don't have equivalent systems
 - No one doing this super well
 - Need action taken yesterday; legislation adjourns May 20th
 - Also need to develop Youth Justice Continuum, incarceration of mentally ill young people, etc.

- 11 = majority vote passes
- 5 abstentions
- Cici asks Eric to explain state agency abstentions
 - State agency employees are required to not take positions on legislative positions not consistent with Governor's budget proposal; Governor can't direct state employees to advocate for position; separation of official roles and group responsibilities; similarly, when issues pertain to agency activities, state agencies would refrain from weighing in on recommendations from others in consideration of single hierarchy that reports to Governor; some advisory groups have ex-officio capacity and some have non-voting capacity; want to recognize that current structure has state agency reps as full members who will abstain in such matters; appreciates this is confusing
 - Cici thanks Eric for the explanation

VII. Updates on Bylaw Work Group – Cici Hughes – 12:15 – 12:25 (10:40)

- Group met to review language
- Decided that rather than address one amendment at a time, group will convene this summer to review all needed changes and bring back to members for future voting
- Members agree this is a better approach

VIII. Workgroup Meeting Updates – Cici - 12:25-12:30 (10:32 out of order due to speaker time)

- Family Systems – Anna Lynn – no further updates
- Integrated Care and Access – Mary Kjolsing – fine tuned recommendations and will have them submitted soon
- LAC – Sierra Grandy (not here) – Alison says group is having confusion around links and information to join the meeting; working on recommendations; will be similar to previous recommendations that haven't been addressed
- MH and Juvenile Justice – nothing new
- MH in Schools – Amy Jones – no further comments; (Britt Olean) hoping to give report on teacher relicensing requirements
- Outreach to Diverse Communities – will have recommendations in writing to members to review; thanks Lisa for acknowledging this important work
- Recovery Supports – Angie Schmitz – nothing additional

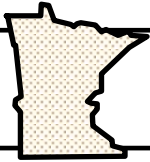

- Shanna Langston – DOC – focused on MMA recommendations; MHU pilot program for county jails and people with serious MH needs can contact DOC for limited spot on pilot starting June 1st for referrals
- Eric Grumdahl – DHS – Gov Wahls announced Tiki (?) Brown will be first Commissioner to Lead Dept of Children, Youth and Families and will start July 1st; she is an amazing leader so this is very exciting; legislative session just ending; language in both education and HHS omnibus for clarity around school social work language and Medicaid billing; working on state amendment language;
- Tom Delaney – MDE – opening applications for 6th cohort of schools in collaborative innovation and improvement network to work on comprehensive MH in schools; working to speed transfer of data and knowledge within networks for better services and including with clinical providers; scaling up innovations in schools; applications online (address in chat); MDE awarded student support pipeline grant to 10 programs (press release link in chat) to increase BIPOC people in school support positions to build representative workforce; MDE will post another RFP for applications for remaining \$400k and will prioritize school nursing and counseling;
- Anna Lynn or Alyssa Greene – MDH – put out toolkit for May MH month; partnered with U of M to train team in model called COMET to build community connections to support one another; have more than 400 already signed up; building set of tools and curricula to center on mental health; have suicide prevention model and building out promotion of these models; Alyssa shared updates on pediatric health resources; SHIP team working on wellbeing and workplace; have press release about expanding model jail program and 17% of young people have had this traumatic experience; some districts have 25% with self or parent having been incarcerated; Alyssa Greene: pediatric MH access program; MDH collaborated with DHS on early childhood MH collaboration group and brought to local providers with 5 groups running to have local MH supporters feel more supported and having better options for resources, plus building relationships for warm handoffs; starting 2nd cohort in July and presenting at this week's MH conference; contact Alyssa for anyone interested in public MH connections with this programs (check chat)
- DEED – Claire Courtney – no new updates; May is MH Awareness Month; endorses toolkit from MDH with IPS providers; doesn't look like provider efforts to extend IPS programs will be successful so will take these up again next session; reach out with any questions

- Triasia: she wants to connect with people doing youth MH work; graduated with masters project on black suicide prevention; wants to continue efforts; did focus group and wants to do more to see what's needed to eliminate black suicide
