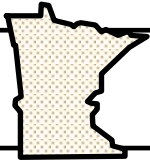

V. DHS Updates – Claudi Daml introduces Eric Grumdahl (DHS) 10:25 – 10:40 (10:12)

- Eric introduces self as Assistant Commissioner for Behavioral Health (BH), Housing and Deaf and Hard of Hearing Services
- Big update today then he's got to leave for Public Health Directors meeting
- DHS is undergoing organizational change with new DFYC agency
- Commissioner Brown is now designee for Commissioner of new agency, presently leading Children and Family Services; started out as intern with DHS
- Separating into new agencies
- Commissioner Harpstead announced separation of administrative areas – one focused on homelessness, housing and support services and behavioral health; timing to be determined
- Will recruit for new Assistant Commissioner of BH; Eric appreciates everyone's help promoting this position
- Commissioner asked Eric to lead until a new AC is on board
- Why now? dramatic growth in homelessness and behavioral health plus opportunities and much anticipated intersection between new agencies
- Alison mentions Tobias Wild; DHH division will move with this transition

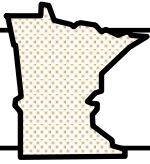

- Putting forward previous recommendations which were not previously acted on in legislature
- Expand access to wraparound care; has grown in prominence in recent years; evidence-based practice; develop grant funding for counties to expand on this system of care model developed through SAMHSA
- Expand family peer support opportunities; much opportunity to grown ancillary support for families; families need help to manage stress and to create nurturing environments for children while managing additional risk factors such as incarceration and other children experiencing MH issues; want this support earlier in their journey; offering 1:1 peer support and information being offered about MH services
  - Elliot asks: is system of care program still in existence and does wraparound need to tie into this?
  - Eric: unsure but grant to support has ended; aware of local level activity to advance this same kind of thinking in Hennepin and other counties
  - Anna: system of care was built into communities so this would be in addition not instead of
- Grow family support in schools; centered on families needing more support; recommendation to provide grant funding to schools to develop family outreach; FAST (families and schools together) is one example of such a program (Lisa Hoogheem); especially for families with additional stressors
- Building community-integrated care to support families; build capacity to offer natural supports through mentoring and supports where kids and families are: school-linked MH, coaches, youth workers, faith communities to implement evidence-based programs into existing work; MDH advanced proposal at last session that got to Omnibus bill last session then disappeared; several orgs do this work already; there are evidence-based and emerging evidence-based programs that would help communities to offer this care; “democratizing MH” is the coined term; to reach everyone across the continuum not just those in crisis, but those who want to stay in track; promotion-ordered; grants supports to train community members then implement and evaluate
  - Lisa: need to include in recommendations that agencies should be culturally-specific providers or staffed by culturally-specific providers, similar to CEMIG grants
  - Dr. B: this is encouraging, need to collaborate more to include such recommendations stemming from the Outreach to Diverse Communities workgroup
  - Dave Lee: state has been working on motivational interviewing and other evidence-based practices as part of a program and wonders if there’s overlap here for funding;
  - Sara offers to do group email to connect with contact from Dave; Megan Waltz involved in work;

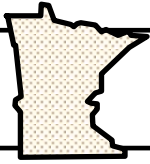

- Anna is somewhat familiar with this program and has seen other, non evidence-based work on their proposal
- Dave: has staff involved in this work who are frustrated with the limit of reach on other program
- Anna: is nationally maintained database
- Sara asks Anna to put email in chat for people to connect and offers to connect those interested in email chain
- Jode: one area of need is adolescents (see chat); her warm line gets 2400 calls per month, now have bilingual text line; have youth calling Wellness in the Woods and recognizes huge need for adolescents to go to; need someone to listen to them and safe space to go to; parents, sheriffs, social workers and elderly community members also call their hotline
- Claudia points out typo in recommendations
- Sarah Driever: are there any insights on issue of funding (PACER) who can fund groups, but parents may feel tokenized due to workforce shortages – not enough case managers to go around; must go to peers due to this absence; is this the right place to direct funding – in-system county services to fill gaps first and then moving out?
- Anna: funding isn't an either/or; can sometimes fund from back end, but don't have to do this; proposals aren't replacing any other services, but adding to; intended to be for broader population that may not be connected to or aware of case management; people who've got stressors in life and needing natural supports or skills and opportunities for parents to connect;
- Sarah says this is helpful; thank you
- Recovery Supports – Angie Schmitz
  - Claudia says Angie's group had difficulty with attendance and Angie took on new position with state and wasn't able to lead workgroup and to write recommendations
  - In lieu of having no recommendations, suggestion to look at previous recommendations to move forward
  - Claudia says affordable housing is lacking here and suggests having a recommendation for this; offers to reach what was previously recommended
  - Increase access to affordable housing across MN; (reads recommendation) to increase funding for Bridges program and housing with supports for adults with SMI and increase funding for outreach services for SMI and SUD to access services
  - Asks members to help update for submission now
  - Eric: doesn't remember timing but says 2023 and 2024 legislative session had fairly significant proposals in this space so would recommend significant redraft would be needed to take this into account
  - Claudia asks if any member is familiar enough with this area to suggest updates
  - Eric: DHS and MN Housing and Interagency Council on Homelessness are kicking off engagement commitment focused on looking at current Medicaid and Housing

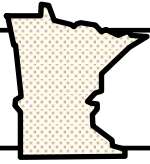

- Stabilization Funding (4 years) to make this stronger and which may require legislative and CMS funding to approve; identifying long-term financing for housing rather than grant funding or funded through Housing Support Program; want to explore broader use of Medicaid and what would be allowed toward housing; want to hear from partners what might be possible;
- Damir: is this building off waiver for people coming out of criminal justice system?
  - Peter: more through health-related needs; 1115 is most complicated for approval; all living in same environment and CMS is open to revisiting and DHS wants to take advantage of the door being open
  - Sarah: one area of growth is supporting those with dual diagnoses and addiction issues who need residential support, especially if they've got history of aggression or self-harm; is it worth reshaping focus to include such instances identified in study?
  - Damir: how to take theoretical frameworks and implement? Initiatives break down because key stakeholders don't understand this process
  - Eric: says yes, this is an opportunity
  - Damir: built facility in Fridley for people with neurocognitive disorders and was awaiting funding but hasn't received it; appealed to Commissioner; seems to be lack of understanding; other facilities have total of 30 beds so there is a need in this space; co-occurring disorders; \$3m at stake
  - Claudia: is there interest in re-working a recommendation for this workgroup?
  - Dr. B: wants to be clear because one of their recommendations is around housing people with MH and SUD and for people returning from incarceration; wants clarity on issues being addressed; wants culturally-specific dollars called out
  - Claudia says some form of combination would be helpful
  - Eric: doesn't want to say they've got everything they need; there is more work for additional funding; disparities in homelessness are some of the most egregious
  - Dr. B: Is there legislative language targeting BIPOC population for culturally-specific services needed?
  - Eric: Feels like there's an opening for 2024 recommendations to focus on this; knows there's an appetite for more funding for specific populations and desire to expand Medicaid; bright bulls eye on this topic
  - Dr. B: how does housing work? Is there housing to meet needs?
  - Peter: not just housing stock but landlords willing to take on such renters who've got government assistance; there is housing shortage as well;
  - Dr. B: if housing was built specifically for these populations would it be possible for law to say if they qualify they must be accepted?
  - Peter: would love to see law say this
  - Damir: tried to address this issue but couldn't figure out zoning, fire safety measures, etc. because stakeholders couldn't agree; need to figure out residential zone alignment; didn't even get to funding discussion; from a business standpoint

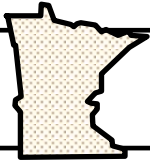

- Eric: will be much collaboration in new DHS agencies; as we think about recommendations for 2024, all topics feel right for recommendations, but DHS as state agency can't draft language but is happy to advise or assist others
- Sarah: can they partner with legislators such as Jim Abler in this space of cultures and recovery?
- Claudia: current timeline is to approve recommendations to go to Governor and legislators in today's meeting; proposes interested members finessing language to present in next week or two for approval of housing topic within Recovery Supports and allowing leadership team to consult with DHS on final language; is this satisfactory for group? Opposition? Concern?
- Interested: Damir, Sarah, Dr. B and Dani – Sara will connect these
- Outreach to Diverse Communities – Dr. B
  - Recommendations: kept recommendations that didn't get adequate support and added new areas such as housing which member Gary helped advance
  - Expand culture and ethnic minority infrastructure grant (CEMIG) for increased funding: licensure support, providing training and support to people trying to get licensed and providing direct services to people experiencing no insurance or who are underinsured;
  - Develop more community support resources for housing for BIPOC populations and those with MH and SUD
  - Offer plan to make housing accessible to those previous incarcerated
  - Increase peer support specialist and recovery support specialist pay; current pay is low
  - Provide monies to orgs who want to hire, train and engage in specific services such as HARMS, CTSS, school-linked MH and SUD to offer cultural support; also CBBSC
  - Look at legacy for health equity to support parents and kids and CPS involvement; addressing level of diversity competency in child protective system
  - School-linked MH; increase access to technical assistance to parents and other groups that have been left out to encourage access to school-linked MH
  - Orgs working to become 245I populations for SUD and MH
  - Claudia asks if recommendations are written down; hasn't seen any submissions to be reviewed or voted on; Dr. B to send recommendations no later than Monday
  - Rod: wants to see written recommendations; couldn't clearly hear Dr. B to fully understand recommendations
  - Claudi points out this late review misses today's vote; poses problem if members don't have clear sense of recommendations to move forward; reminds there is no meeting in July and need to have recommendations into publisher by August; doesn't want to have special meeting; ask Dr. B. if she's got any written submissions to send to Sara
  - Dr. B; only has rough draft; reminds that previously when recommendations were outside the voting timeline, had recommendations advance in principle and allowed further work by group; wonders if more work to integrate is needed or

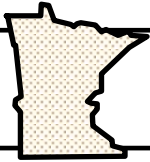

- just stand alone recommendations, which are easier but which also may make less sense to legislators and leave to leadership for final decisions
  - Claudia says Dr. B's audio was inconsistent, leaving gaps in group's understanding of recommendations; asks Dr. B to send over what she's got now to avoid having to call a special meeting
  - Dr. B will send at end of meeting
  - Cici asks for title of recommendations and brief summary of each; to be expanded on later
  - Rod: says group does this every two years; purposely put Outreach as first topic in previous report due to importance of recommendations; it's important for this group to know specifically what this group is recommending to emphasize important topics
  - Dr. B says thank you
  - Local Advisory Councils (LACs) – Sierra Grandy (workgroup chair)
    - Three recommendations
    - 1 = expansion into community participation requirements for LACs; as written is limited; language is outdated; asking for community input and others to highlight wider variety of interests in LACs; “individual with experience of MH”
    - 2 = inclusive person-first language rather than “consumer” to match other language
    - 3 = adding equity to adult and children's mental health advisory groups; recommend children's statute language matches adult language – “coordinate its review, evaluations and recommendations regarding local mental health system with the state advisory council on MH”
    - Claudia asks if people have questions;
    - Jode: wasn't able to attend yesterday's meeting but notes Sierra and Alison worked hard to develop this language
    - Dave Lee: appreciates inclusion of adult MH initiative and AMHIs assessing community needs and thanks Sierra for this important work
    - Sierra: thanks Dave for his input on that recommendation
  - Lisa asks if any workgroups have revisions to previous submissions; none voiced
- VII. Vote to confirm legislative recommendations – Claudia - 11:20-11:40 (11:23)
- Claudia says to move forward with other vote first to give Dr B time to submit something in today's meeting
  - (12:47) pulling up Dr. B's 5 recommendations:
    - Increase financial support for peer recover support specialists provider program
    - Provide funds to BIPOC orgs that will render funding and technical support for their engagement in service delivery
  - Claudia says due to absence of quorum this group is unable to vote on these important recommendations and will need to call a special meeting to approve; encourages every workgroup to have formalized recommendations submitted on the provided forms

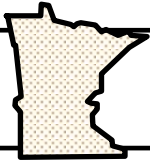

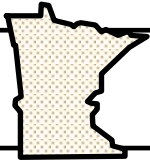

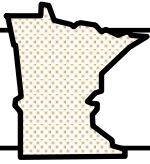

XI. State Agency Updates – Cici Hughes - 12:10 – 12:30 (12:18) – please give updates on recently passed legislation

- Shanna Langston – DOC – MRA for incarcerated people to be involved in programming; not active yet; Redwing looking at certified adults who are youth and circumstances to bring them to receive services in Redwing until their 18<sup>th</sup> birthday
- Eric Grumdahl – DHS – already done
- Tom Delaney – MDE – accepting applications from schools to participate in collaboration and innovation network around comprehensive school MH services which is evidence-based and adopting a model of implementation; encourage your schools to get involved – closes June 27<sup>th</sup>; more funding for colleges and universities to increase # BIPOC students entering into certification programs (social workers, counselors, etc.); more info is available and Megan Legasse is contact; doing surveys to prepare for next recommendations; 2 surveys: 1 Mn Disability Inclusion and Choice (Mn Olmstead Plan) Survey – will combine state agency supports for people with disabilities and wanting information on inclusive schools, communities, residences to feedback and input; survey for people in high schools (**info in chat**); feedback on One Mn Plan; (**link in chat**); legislation has been sorted through have shared legislation with DHS to improve MH services; reach out to Tom with questions
- Anna Lynn or Alyssa Greene – MDH – teaser for colleagues in Health Economics who are finalizing report on BH transfer and discharge and delays and boarding at hospitals; no updates on legislation
- DEED – Claire Courtney – not present
- Others – none
- Anna: questions on access to services for adolescents without parent support – MDH doing outreach on this after calls from providers who are unclear on this legislation; wonders if DHS and others are also getting feedback on this
- Susan: says this is surprising knowing that MH, pregnancy and STD care are all available without parental consent; may be useful to find out demographics from questioning providers
- Anna: there was a recent change this past year in this provision
- Rakesh: what was the recent change in law?
- Elliot: outpatient services

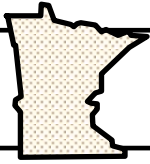
- Rod: have 8 legislative assistants that give them updates and MH was big for AMC this year; Rod reads updates: tax mega bill includes children in crisis stabilization; need covered benefit for residential crisis stabilization with culturally relevant services that is evidence-based; bill includes DCT, SUD facility, and other elements; AMC won't refer people until beds have been added; \$1.32M in health innovation grants; ongoing DNMC (does not meet medical criteria) costs to counties are still limited;

XII. Updates from Members – Lisa Hoogheem - 12:30 – 12:50 (12:37)

- State Fair workgroup update: working with NAMI; have 40 vendors; partnering with Native American drum circles for opening and closing; have artwork and t-shirts ready to order (PayPal only); shirts are \$12 – regular or spun cotton; pick up at State Fair (Aug 22<sup>nd</sup>) Dave is willing to bring shirts into meeting as well; Sara helped organize volunteers (16 slots from council and subcommittee – 1<sup>st</sup> start at 5am – need names ahead of time for access clearance – also have midday and 5 people at end of day – will receive free t-shirt); mentalhealthatthefair.org = website; hope Gov and/or Lt Gov attend to read MH Day proclamation; thinks shirts are unisex
- Lisa thanks Dave
- Peter Fischer – not many \$s in this year's legislation (only \$9m) but spent more than this in MH area; \$3m for respite and \$3mschool-linked BH grants one-time funding; added \$8m to increase MH Medicaid rates but need more to level out;
- Rod said they added \$10m to improve DHSs computer systems to update which is long overdue; these are the systems the social workers work in to do their work
- Dave: will take millions to get it fully updated
- Peter: Rep Noor came from IT in DHS so understands this well
- Rakesh: was funding based on formula
- Rod: this funding will improve entire system for dissemination to counties and providers

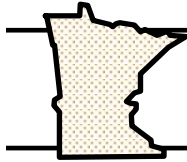

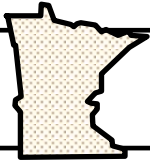
