### Resident and Family Survey Updates

### Updates from Vital Research: data collection progress

- Tier 1 resident surveys began in February and are scheduled to end March 31.
  - Tier 1 includes 192 facilities located in Northern MN.
- 70 facilities completed as of March 4, 2024
  - 1149 AL interviews completed (not counting incompletes)
  - 69 facilities met MOE
- Vital Research will continue to conduct Tier 1 surveys into April as needed.

# Updates from Vital Research: data collection progress continued

- No facilities have refused to participate in surveys.
- First batch of family surveys was mailed the week of March 4.
  - 80 facilities included
  - 2200 representatives included
- Tier 2 surveys are scheduled to begin in April and end June 30, 2023.
  - Tier 2 includes facilities located in the seven county Twin Cities metro area.





### **Assisted Living Report Card Updates**

### Assisted Living Report Card usage

- The AL Report Card was publicly launched on January 29, 2024.
- Advisory group members have expressed interest in learning how many people have viewed the report card since launch.
- 181 unique users visited the website between 3/7 and 3/12.
  - The data available to DHS currently is limited.
  - DHS is working with MNIT to obtain more data ongoing and will provide updates to the advisory group at future meetings.

# Responding to advisory group input: facility rank

- Providers raised concerns about displaying "facility rank" on the report card.
- UMN recommended removing facility rank based on their analysis.
- DHS decided to remove facility rank from the report card.



### Responding to advisory group input: facility size

- Providers raised concerns that 2024 quality of life (QOL) scores will be based on surveys being conducted in facilities with less than 20 residents for the first time.
  - UMN will analyze 2024 QOL survey data by provider size before ratings are published.
  - DHS will decide whether to risk adjust QOL scores by provider size based on UMN's recommendation.
- Consumer advocates and providers recommended adding facility size to the report card.
  - DHS has decided to add a facility's licensed capacity to the report card.
  - This change will be implemented in a future update.

# What's in scope for the Assisted Living Report Card?



### Responding to advisory group input: reconsiderations

- Providers raised concerns that publishing ratings based on MDH's initial licensure survey findings will hurt providers whose reconsiderations result in a changed or removed citation.
  - Statutes provide 60 days for MDH to make a determination on a reconsideration. According to MDH, there is currently a delay of several months.
  - DHS is working with MDH and UMN to explore options that will allow us to provide consumers with timely information while accounting for the reconsideration process and timelines.

# Revised timelines for additional report card ratings: MDH licensing survey and investigations findings measures

- DHS plans to begin publishing MDH licensing survey and investigations findings measures in early 2025.
  - New ratings will be added quarterly.
- DHS will use licensing surveys completed on or after July 1, 2024 for ratings.
  - Communications plan includes GovDelivery e-mail and MDH website announcement to AL providers before July 1.
- DHS will use a threshold for star ratings that will be updated annually.
  - UMN is establishing a star rating threshold for 2025 MDH licensure ratings based on surveys completed between September 2021 and December 2023.

# Revised timelines for additional report card ratings: Resident quality of life and family satisfaction survey measures

- DHS plans to use a threshold approach for star ratings.
- 2024 resident and family survey ratings will be published semi-annually.
  - Jan. Jun. 2024 QOL survey ratings will be published in late 2024/early 2025.
  - Jul. Dec. 2024 QOL survey ratings will be published in the first half of 2025.
- In the future, thresholds will be updated annually, and scores will be published quarterly.

# Goals/objectives

- Establish a methodology for weighting tags according to scope and severity and developing a system for calculating scores and star ratings.
- Determine the need and parameters for implementing risk adjustment.
- Define a schedule for updating scores across all measures, including MDH licensure surveys and resident and family quality of life surveys.



# How we calculate scores based on scope and severity

- For national skilled nursing facility provider ratings, CMS calculates a health inspection score based on points assigned to deficiencies identified at each provider's most recent recertification.
- We used the smaller values listed in this points system.

# Calculating 5-star ratings for licensure surveys

- We propose the 5-star rating system:
  - 5 Stars: Mean plus 1½ standard deviations or top 7%
  - 4 Stars: Mean plus ½ to 1½ standard deviations
  - 3 Stars: Mean plus or minus ½ standard deviations
  - 2 Stars: Mean minus ½ to 1½ standard deviations
  - 1 Star: Mean minus 1½ standard deviations



# Calculating 5-star ratings, cont.

- Once a facility has 2 eligible surveys, we propose weighting surveys using a similar method that CMS uses for nursing homes (surveys completed prior to 7/1/24 will be excluded).
  - Current survey will be weighted 2/3 and the previous survey 1/3.
  - If there is only 1 survey, it will be weighted by 1.



# Peer approach for licensure surveys

 A peer group is a group of facilities with the similar characteristics. We explored: 1) geography, 2) size, and 3) licensure type (ALF, ALF-DC)

Facility Size**	Geography**	License Type
Micro (1-5 beds)	Twin Cities Metro (TCM)	ALF
Small (6-50 beds)	Rest of the State (ROS)	ALF-DC
Large (51+ beds)		



<sup>\*\*</sup> we recommend peering by size and geography

# Response to recommendations

- What are your responses to our proposed recommendations?
  - Weighting by scope and severity
  - Standard deviation for star ratings
  - Combining 2 rounds of licensure surveys and weighing them differently
  - Peering recommendations



# How to establish a scoring method with rolling data collection

- Licensure surveys are conducted every 24 months using rolling data collection
- This may result in the earliest participants getting more stars for lower scores and the later participants getting less stars for higher scores because of the differences in sample composition (could go either direction).
- A way to lessen this issue is to develop thresholds that will be used as a benchmark for all facilities. Thresholds are based on the previous round of survey data.




# Calculating a threshold from licensure surveys

- What is a threshold?
  - For our purposes, a threshold is a fixed score that defines the boundaries for each 5-star category for a given peer group.
    - Each 5-star category will have an upper and lower boundary
      - An example: 5-star (0-16),4-star (17-39), 3-star (40-83), 2-star 84-127) and 1-star (128 or higher)
- Licensure survey thresholds will be communicated to stakeholders before thresholds will be appliedinforming all of benchmarks for the coming year
- Thresholds will be updated yearly



# Frequency of updates for <u>licensure surveys</u>


Thresholds will be updated yearly using the previous 2 years of licensure survey data



 Tentative schedule: thresholds are calculated using the calendar year (Jan-Dec) and they will apply to surveys in the following state fiscal year (July-June). Every year, thresholds will be applied to surveys starting in July and reported to providers ahead of July.

# Frequency of updates for <u>licensure surveys</u>


 <u>5-star ratings:</u> The long-term goal is to update licensure survey 5-star ratings quarterly. <u>Below is an example</u> timeline





# Frequency of updates: resident/ family surveys

Thresholds: In 2024 and 2025, 2 thresholds will be used





# Frequency of updates: resident/family surveys

• <u>5-star ratings:</u> The 2024 round of ratings will be published semi-annually. The goal is to move towards quarterly updates of 5-star ratings.
