  - iv. Education for case managers at the prison.
  - v. Connect with the parenting coordinator at the Shakopee prison facility.
  - vi. Juveniles involved in the child protection system experiences.

- 1. Survey children/foster youth regarding needs met.
- vii. Sponsor or host Foster Parent Awareness Month or appreciation meal.
- viii. Review county website to add links and resources for families in the Chisago County area.
  - 1. Would need someone to do continuous updates if moved forward.\*
  - 2. Foster care and criminal systems to have more knowledge or protocol on what to do with children with high needs or problematic behaviors.
- ix. Dig into medical exam data on the public dashboard and review if a protocol is needed to accurately reflect the work being done to ensure child in out-of-home care are receiving a medical exam per statute.
