<p>Meet Hennepin County Human Services Director Kwesi Booker</p>	<ul style="list-style-type: none"> • Reduction Act implementation in Hennepin is going well • We have a group working on deciphering the legislator • Other groups working in specific areas in CFS • We have been in conversation regarding the piolet populations • If we are working with changing the case continuum in AA Family's and Native families who are not ICWA • Starting Jan 1st • It will give us time to allocate staff and shifting priorities • We identified where our implementation teams will be • This also an opportunity for courts and CAO receive the necessary training to implement the act • 30% increase first quarter in implantation, then by 10% each quarter going forward until we reach 100% • It will only be for new intake cases going forward
