

# HCBS Provider Capacity Grants for Rural and Underserved Communities

Seventy-one Minnesota organizations will be able to increase their capacity to serve older adults and people with disabilities in rural and underserved communities through the Home and Community-Based Provider Capacity Grants funded by the Minnesota State Legislature. Grants are awarded to new organizations looking to become an HCBS provider or to existing providers to expand their services or increase the number of people they serve. A total of \$8.9 million has been awarded for grant period of December 2024-June 2026. Over 230 applications were received for this specific round of grant funding.

Through these grants, organizations will increase their ability to provide HCBS in Minnesota to one or more of the following focus communities:

- American Indian and indigenous people Inclusive of Minnesota sovereign tribal nations;
- Asian and Pacific Islander;
- Black and African-born;
- Latine;
- Lesbian, gay, bisexual, transgender, queer, or questioning (LGBTQ+); and
- Rural and regional centers outside the seven-county metro area.

Expand their organization's ability to provide HCBS through one or more of the following programs:

- Alternative Care (AC) Program
- Brain Injury (BI) Waiver Program
- Community Access for Disability Inclusion (CADI) Waiver
- Community Alternative Care (CAC) Waiver
- Community First Services and Supports (CFSS)
- Developmental Disabilities (DD) Waiver Program
- Elderly Waiver (EW) Program
- Essential Community Supports
- Housing Stabilization Services
- State Plan Home Care Services

Or, to expand an existing organization's service capacity by expanding into one or more Home and Community-Based Services that the organization did not previously offer before December 2024. #### **Central Minnesota**

A Home for the Day LLC \$78,504 A Home for the Day LLC is an adult day service provider in St. Cloud serving seniors with disabilities 55+. They offer a fun and safe "club" to do social activities providing meals, snacks, transportation, health monitoring and thematic programming, while their caregivers receive respite. Agan Home Care Inc \$145,984.00 Agan Home Care provides comprehensive care services to individuals with various needs, focusing on enhancing their quality of life through personalized care plans and professional support. Agan Home Care aims to expand its Integrated Community Services (ICS) and Housing Stabilization Services (HSS) to serve more people in rural and underserved areas of Minnesota, specifically in St. Cloud and surrounding counties. AJ Schmitz AFC \$126,208 AJ Schmitz AFC was founded in May 2020 and is located in Stearns County. They are licensed as a Family Adult Foster Home providing care to two male individuals with complex medical needs. With grant funding, they will include new licensure of Individualized Home Supports to meet needs of adults with complex needs in the community while in their own home. Additionally, providing a handicap accessible van and a wheelchair ramp will maintain functional capacity and provide individualized person-centered care of home and community-based service participants.

Brainerd Lakes Area Behavior Support \$70,014 offers individualized in-home behavior management, skill development, and Facilitated Person-Central Planning to children and adults in Crow Wing County and surroundings areas. Grant funding will support streamlining administrative and bookkeeping processes, provide supplies and additional training for Person-Centered Planning, as well as help cover travel time and expenses. Monarch Support Services \$150,000 Monarch Support Services is a woman owned business and has been an approved DHS provider for Minnesota Health Care Programs (MHCP) Provider Eligibility and Compliance Services since March 7, 2022, providing 24-hour Emergency Assistance, Housing Stabilization Services, and Consultation Services. Grant funding will be to hire 4+ additional Housing Coordinators to serve in rural Minnesota, as well as expand Transitional Services to purchase an enclosed trailer to assist clients with moving.

**Sisu Living LLC** \$92,447 Sisu provides 245D services, offering 24 Emergency Assistance, Homemaking, and Individualized Home Support with and without training, and they have two Integrated Community Support settings in the St. Cloud and surrounding communities. Aimcare, LLC \$149,764 Aimcare is an HCBS licensed provider that specializes in providing services for members of the East African community in the Twin Cities, particularly the Oromo, Ethiopian, and Somali communities in Anoka, Dakota, Hennepin and Ramsey Counties. Aimcare provides a wide-range of HCBS services, including Homemaker, Individualized Community Living Supports (ICLS), Individualized Home Supports, Independent Living Skills (ILS), In-Home Family Support, Night Supervision, Personal Care Assistance, Personal Support, and Respite.
