Workgroup Breakout Sessions

- I. Members were in breakout sessions
 - a. Workgroup 1 (Objectives 1 and 2)
 - b. Workgroup 2 (Objectives 5 and 6)

Workgroup Report Back

- I. Workgroup 1 (Objectives 1 and 2)
 - a. Currently gathering national standards related to Mentally III and Dangerous (MI&D) commitment procedures
- II. Workgroup 2 (Objectives 5 and 6)
 - a. Surveys have been sent to individuals and their families regarding their experiences at the Forensic Mental Health Program (FMHP), as well as to county agencies and county attorneys
 - b. Discussion highlighted the lack of information available to judges and examiners regarding risk assessment and alternative options aside from forensic commitment
 - c. The workgroup is seeking a measurable way to assess what additional information is needed

 - c. Sue Abderholden
 - i. Clarified that the purpose of the "open mic" session is not to contest current placements but to identify resources that could have prevented commitment
