#### Service provided:

Anishinabe Legal Services is a 501(c)3 non-profit organization that provides free legal services to low-income community members residing on or near the Leech Lake, Red Lake, and White Earth Reservations in Northern Minnesota. They provide free legal services in a wide variety of case-types, including family law, housing, child protection, consumer law, elder law, and more.

Services provided for Social Security Advocacy include advice or initial consultations, assistance with filing initial applications and understanding forms, filing appeals for



reconsideration and hearings, representation at administrative hearings for disability, overpayment assistance, cessation cases, childhood disability cases, outreach services and referrals.

Anishinabe Legal Services has been a contracted grantee with DHS for over 15 years. With this collaboration they have been able to assist people in their community without charging their clients for Social Security Advocacy Services.

#### **Contract spotlight: Record retention**

All Social Security Advocacy Services grantees are required to implement and maintain a record retention policy.



All client files, records, and documentation associated with the DHS contract must be securely retained by the

grantee for a period of six years from the date of expiration or termination of the contract, or longer if required by applicable law, after which the documentation must be properly disposed of. This DHS contractual obligation can be found in Attachment A - Data Sharing and Business Associate Agreement, section 2.2.H, and subsection 2.6.

Grantees are also subject to the accounting of disclosure requirement as described in 45 CFR 164.528, "Accounting of disclosures of protected health information". When requested, grantees shall provide to the state such documentation.

## Report your agency changes immediately

SSAS grantees are responsible for reporting any address or bank account changes to Minnesota Management and Budget (MMB) immediately. Delays in reporting information to MMB will result in DHS payment delays for your Social Security

approvals. You must also report all address and employee changes immediately to your assigned coordinator so that we can update our online directory and the SSAS payment system.

To report changes, you must log on to the Minnesota supplier portal.

If you have not contacted MMB to set up your agency to receive payments by DHS, you must go to MMB's webpage to start this process.

#### **New conditions added to Compassionate Allowance List**

Effective 8/12/2024, Social Security has added or updated the following conditions to their Compassionate Allowance List:

- Adult heart transplant wait list Status levels 1-4
- Bainbridge-Ropers syndrome
- Plasmablastic lymphoma
- Costello syndrome
- Histiocytic malignancies
- Neonatal Marfan syndrome
- Snijders Blok-Campeau syndrome
- Child heart transplant wait list status levels 1A/1B
- Histiocystosis syndromes
- PACS1 syndrome
- Renal Medullary carcinoma

If you are currently working with a client who has any of these conditions, be sure to flag the case as Compassionate Allowance to the relevant Social Security office or the Disability Determination Services. For further information, review POMS <u>DI 23022</u> <u>TN73</u>, summary of changes.



## **Social Security Administration updates**



#### Disability collateral estoppel policy

Effective 7/13/2024, Social Security has updated their collateral estoppel policy to adopt prior favorable finding of disability in a subsequent claim by the same individual for a different disability benefit or SSI payments, as long as certain criteria are met. Read emergency message EM-24033 for further information.

#### **Changes to accessing Social Security's online services**
