Contract spotlight: Referring individuals to apply for public assistance benefits

All Social Security Advocacy Services contracted grantees should be referring individuals to apply for Minnesota Department of Human Services (DHS) public assistance benefits such as cash, food, and health care while you help them apply for Social Security disability benefits or



complete a continuing disability review and wait for a decision from SSA. See section 2.4.1C of your contract.

To refer an individual let them know that they may qualify for additional income, food, and health care assistance. For more information and to apply they can go online to MNbenefits or contact their local county or Tribal Nation health and human services office. To find a county or Tribal Nation human services office use this online directory.

New Social Security appointed representative rule

As of Sept. 30, 2024, all appointed representatives assisting SSI/SSDI claimants using the <u>SSA-1696</u> form must now register as a representative.

To register you must use the <u>SSA-1699</u> form and fax it to Social Security's Office of Central Operations. You will only need to register once using the SSA-1699 form unless your information changes. Once you are registered, you will receive a

representative identification number. Moving forward, this number must be entered on all SSA-1696 forms you and your client complete.

Additionally, once you are registered you can then enroll in the <u>Appointed</u> <u>Representative Services (ARS) system</u>. The ARS is an application that allows appointed representatives to view electronic folder documents in real time, download the contents, and upload documents directly into a claimant's folder.

Continuing disability reviews resume

Social Security has announced that effective Oct. 18, 2024, they will resume processing continuing disability reviews (CDR).

CDR processing will be done in two stages. The first stage will be to resume processing CDR cases that were pending at the time of the CDR pause. The second stage will be to resume receipt, assignments, and processing of all CDR workloads.

2025 cost-of-living adjustments

Social Security recently announced benefits will increase in 2025 by 2.5 percent. Some increases you should be aware of are:

- Substantial gainful activity (SGA) amount will increase to \$1,620/month for nonblind persons.
- SSI federal payment standard will increase to \$967/month for an individual and \$1,450/month for a couple.
- Review the 2025 COLA fact sheet for the full list of increases.

This year, for the first time, Social Security beneficiaries will receive a newly designed and improved cost-of-living adjustment, or COLA, notice. Notices will start to be issued in December 2024. Social Security Administration updates



Updated Supplemental Security Income (SSI) policy

Effective Sept. 30, 2024, Social Security will no longer include food in the in-kind support and maintenance calculations.

Additionally, Social Security has expanded the rental subsidy exception and its definition of a public assistance household.

New email and text message communications

Effective Sept. 30, 2024, Social Security has updated instructions for collecting customer electronic communication preferences (text, email, or both). Read <u>EM-24051</u> for further information.

Program Operations Manual (POMS) updates

<u>GN 03913 TN15</u>, Individual registration for appointed representative services.

<u>DI 22515 TN13</u> and <u>DI 22515 TN14</u>, Vocational evidence case development procedures. Provides information on what constitutes sufficient vocational information and provides guidance on when additional vocational development is required.

<u>GN 03970 TN21</u>, Suspension or disqualification of representatives. Several POMS sections have been updated including the rules of conduct and standards of responsibility for representatives.
