

Q1 Tell us about yourself, are you....




Q2 Do you live in (or did prior to being admitted to FMHP)..

Q4 What services did the person with a mental illness use prior to being committed as a person with a mental illness that is dangerous (MI&D)?












Q9 Please rate your experience with you or your family member/friend receiving treatment at FMHP.




Complaints about staff being rude or not listening, need more intensive treatment and trauma focused, some stated it had gotten better lately



Q10 For family members/friends: Do/Did you feel included in the treatment and care plans for your family member/friend?








